## Bernie L. Bates, the Name



Bernie Leroy Bates was born April 8, 1944 in Ashville, N.C. to Ms. Ivy Bates. He was raised in High Point, N.C. by his maternal grandparents, Joe Parker and Idell Tussey.

Brother Bates credited his grandparents with instilling in him the value of academic excellence and to living a purposeful life. In 1971, he married Patricia Belton. From that marriage, two sons were born: Bernie, Jr., and Belton Parker. Bernie Bates was initiated into the Omega Psi Phi Fraternity, Inc. on April 6, 1963 through Alpha Chapter, Howard University.

Brother Bates enlisted in the United States Army on May 18, 1965. He was commissioned a Second Lieutenant upon completion of Infantry Officer Candidate School in 1967 and was immediately detailed to service in the Military Intelligence Branch. In 1972, he graduated from Howard University,

Washington, D.C. with a degree in Political Science. While at Howard University and after graduation, he remained extremely active in the fraternity, participating in Scholarship fundraisers for needy kids and supporting other scholarly activities on their behalf. He received his Law degree from George Washington University, Washington, D.C. in 1975 and transferred to the Judge Advocate General's Corps, United States Army in 1976. He was admitted to the Bar of the District of Columbia and maintained membership in the National Bar Association and the American Bar Association.

As a career military officer, Brother Bates attained the rank of Lieutenant Colonel. His military assignments included: The Defense Language Institute of Monterey, California where he studied Mandarin Chinese and combat in the Republic of South Vietnam. He also served at Fort Meade, Fort Holabird, Fort Bragg and in the Republic of Germany and the Military District of Washington. Lieutenant Colonel Bates earned military awards and decorations which included: The Bronze Star Medal, The Meritorious Service Medal, the Army Commendation Medal, the National Defense Service Medal, The Vietnam Service Medal, the Vietnam Campaign Medal, the Vietnam Cross of Gallantry with Palm, the Parachutist Badge, the Army Service Ribbon, and the Overseas Ribbon. Bernie L. Bates, loving Husband, Father, Son, Brother, and family member; as well as esteemed Brother of Omega Psi Phi Fraternity, Inc. died suddenly on August 27, 1984 at Fort McNair, Washington, D.C.

## Bernie L. Bates Foundation, Inc. President's Report December 31, 2021

Directors, as I reflect on the past year, I am quick to recognize the impact of COVID-19 and the resulting pandemic on our Foundation, community, and nation at large.

We began the year with reservation as even then the Foundation found itself in the grips of an unrelenting virus that wreaked havoc on our community and that which we had come to take for granted.

The setting of measurable goals; the creation of marketing materials; and the setting of a social media strategy all took a back seat to the urgent needs of first responders, medical personnel and those who stood on the firing line wrought with the sick and dying. It was into this breech that the Foundation found itself in unselfish partnership with the leadership and chapter members of the Psi Alpha Alpha chapter of the Omega Psi Phi Fraternity, Inc. among a host of others.

As a Foundation, we further wedged our footprint into our community's social fabric. As the year ends, the Foundation's inventory of priorities and accomplishments includes in the following:

- In 2021 the Foundation initiated and expects to see the inaugural occurrence of its Community Recognition/Privilege Award event in early 2022.
- The value of the partnership and communications between the Foundation and George Mason University (GMU)
  was evident through the Foundation's endowment at GMU, a recent article in a GMU publication and the
  invitation for the Foundation to sit on the College of Science Dean's Advisory Board; a Board of community leaders
  with intersection interests with the College, charged with advising the College leadership on enhancing visibility
  and resources.
- 2021 saw a renewed emphasis and push in participation by Foundation supporters via Smile. Amazon, an effort that can be expected to continue in the coming years.
- Purposeful branding activities continued that sought to incorporate the Foundation's image, its presence within
  the community, its Million Dollar Challenge initiative ("Be One in a Hundred") its promotion of Smile.Amazon
  (Make BLB Smile!) and its Combined Federal Campaign efforts.

- Together with the Psi Alpha Alpha chapter the Foundation was able to donate funds sufficient to support the drilling of a clean water borehole in the township of Akwamufie East, just outside the capital of Accra, Ghana.
- The Foundation maintained its Dishonesty Bond, Directors and Officers Insurance, event insurance, and other measures that serve to protect the Foundation's assets.
- In 2021 the Foundation became fully engaged with the Central Fairfax and Northern VA Black Chambers of Commerce and in 2022 expects to find avenues of similarity that can be supported by all parties.
- 2021 also occasioned the opportunity for the Foundation to provide support for a BLB Art Gallery hosting a local artist as well as professional development training via a sponsored webinar series entitled "The Discipline of Now".
- Challenged by the elements and postponements the Foundation was nonetheless able to successfully sponsor the 2021 BLB Memorial Golf Classic.
- In 2021 the Foundation's website was used to spotlight those remarkable individuals who have contributed much to the local community.
- The MobileCause platform has proven to be an invaluable component in the Foundation's efforts to streamline on-line donations, collections reporting and financial management.
- In 2021 Youth Aviation and the Young Airmen Association out of New York City continued to be a point desired engagement that offers promising outcomes for those the Foundation hopes to serve.
- Given past performance and future projections, increasing Foundation assets by no less than 5% continues to be reasonable expectation.
- The Foundation expects to add 10 new participants to its Million Dollar Challenge program in 2022.
- The Foundation will conduct several hands-on-training topics for Board members in 2021.

I would be remiss to not make honorable mention of the hard work and dedication of Director Hector Sheppard in the organization and execution of 2021's virtual BLB Scholarship and Recognition Awards event. Such out of the box thinking paved the way for other examples of applied tenacity that resulted in above average results. In virtually every case the Foundation's success was predicated on the unselfish commitment of the chapter's leadership and supporting chapter members. Because of such partnerships, BLB's visibility proved quite apparent through activities such as the BLB Memorial Scholarship, Talent Hunt, Stuff the Bus, and Achievement Week Programs.

The Foundation has remained consistent in its support for youth aging out of foster care and the Foundation's Reading for Success program. Both efforts offer great promise as we witness the growing gratification shared with members of the board among youth and staff alike.

2021 also bought with it another the year of COVID-19, and with that came the challenge to rise to the occasion in both giving to and support for the Fairfax community. Once gain, in partnership with Psi Alpha Alpha, the Foundation was able to find a way to target meaningful resources to first responders and others.

The promise in 2022 looks bright as we continue to solidify and make progress in the Foundation's branding efforts through the creation of effective marketing materials, the evolution of the Foundation's signature "Privilege Award" event, the 's use of virtual technology, and the formulation of measurable goals that showcase Foundation results.




## **Governing Documents**

The duties of the various bodies within the Bernie L. Bates Foundation, Inc. (BLB) are determined by the laws of the State of Virginia and by the organization governance policy and Bylaws. This organization governance policy is decided by the Board of Directors (Board). The Board and its Executive Committee are responsible for the management of the Organization. BLB prepares annual and interim financial statements according to general accounting principles. To-date the Board has identified an independent auditor who on an annual basis conducts any required audit. To the maximum extent possible, organization actions and records are taken and recorded appropriately. The decision-making body with responsibility for managing the Foundation are the Board of Director and its designees. The operations of the Foundation are coordinated through the president of the board in consultation with the board's executive Committee. Day-to-day operational responsibility rests within each project area and assigned volunteer members with related tasks.



## **Accountability and Control**



- 1. The President has overall responsibility for the operations of the Executive Committee.
- 2. All financial books and records are kept in a manner consistent with Generally Accepted Accounting Principles.
- 3. All financial books and records are open for public inspection upon request.
- 4. An annual report is prepared within three months after the close of each fiscal year. This report will account for the current financial status of the Foundation and describe all material progress made with the projects of the Foundation.

A copy of the annual report is sent automatically to each major donor (specifically those individuals participating in the Foundation's Million Dollar Challenge program) and to all other donors upon specific request. The annual report is also made available to the public on the Internet, or as may otherwise be requested during normal business hours upon request. The Internet version may be freely downloaded. A non-donor may also have a hard copy of the annual report furnished to him by mail, at cost, upon request.

## **Board of Directors**



2021 witnessed the loss of Foundation Director Emeritus Marion L. "Barney" Barnwell, a pillar in the Fairfax County community and a quiding light, mentor, and counselor to those who were privileged to sit at his table.



The Board under the Foundation Bylaws and principles manage BLB. According to the Foundation articles of incorporation, the Board currently consists of 17 members appointed by vote or by position within the partnering organization. All directors are required to be active with a hands-on approach with the Foundation's activities and to disclose circumstances that might be perceived as a conflict of interest.

- The Board supervises the operation and management of BLB and decides on significant matters relating to strategy, investments, organization, and finance.
- The Board is responsible for overseeing management and for the proper organization operations. It is likewise responsible for overseeing the proper supervision of accounting and control of financial matters.
- The Board has defined a working order, the principles of which are published in the annual report and on the organization's website.
- The Board elects a President and a Vice President from among the Board members.
- The Board approves the organizational structure.
- The Board evaluates its performance annually.
- The Board also reviews the By-Laws annually and amends it when required.
- The Board meets regularly monthly at least ten times a year.
